 Novice- USEA Nov. A, fences up to 2'11", Training— USEA Train A, fences up to 3'3", Prelim-Prelim A test,  
 fences up to 3'6" All tests will be the current—(most recent) version.

**\*Fees: \$30.00 / dressage test, or 2 for 55.00. CTs: 45.00. Late Fee 5.00 per test if \$ recvd after closing.**  
 Refunds after closing date only if slot can be filled. Riders note! Tests ridden out of sequence HC only. Bring SASE for mailed test. Schooling rides: signed entry, Coggins and 30.00. Entries scratched without payment will not be allowed to enter other shows until paid.

**\*Negative Coggins** within 1 year required for entry. Please enclose copy with entry. \*NCDCTA Recognized...USEF rules will apply, except braiding and coats not required.\*Whips may be carried in dressage tests. \*ALL RIDERS MUST WEAR PROTECTIVE HELMETS WHEN MOUNTED.

\*All dogs must be leashed. \*In case of questionable **weather**, call barn office, 387-0097 for recorded message or see webpage, at noon on Friday before the show\* Concessions will be available on the grounds. \*Buckhorn Farm, LLC reserves the right to cancel, combine, or divide any class, change officials, or refuse an entry. Horses demonstrating unsafe behavior may be eliminated from competition.
